

## **2012 Auction Rules**

1. Consigned items will be accepted for the auction from CCA members or their pre-approved guests. Members and their pre-approved guests may bid at the auction with a valid bidder's card.
2. Consignments will be accepted at the annual show or may be given to the auction master in advance of the show. Each item must be accompanied by a completed consignment sheet. These forms are available on our website: [www.coltcollectors.com](http://www.coltcollectors.com)
3. The auction table will be open to accept consignments from 2PM to 5 PM on Thursday, and 8AM to 5PM on Friday, or until our quota is met. Auction items will be available for viewing from 8AM to 5PM on Friday, and from 8AM to 4PM on Saturday. The auction will start promptly at 5PM on Saturday.
4. All consignors will be charged \$25 or 10% of the selling price, whichever is greater. Donated items with a retail value of \$100 or more are always welcome at no charge, and are greatly appreciated.
5. Consignors may place a reasonable reserve on their items when they complete their consignment form. The consignor may not bid on his own item. In the event that a reserve price is not met, the auctioneer will at that time announce the reserve and ask for continued bidding. Should the reserve still not be met, the consignor will be charged a \$50 fee, which will be considered a donation to the club.
6. The sale of all post-1898 firearms must be in accordance with the laws of the state in which the show is held, and comply with all federal laws as set forth by the BATF. The consignor must indicate on the consignment form if he/she is an FFL or C&R license holder. It is the responsibility of all consignors and buyers of post 1898 firearms to execute the proper paperwork between themselves and the purchaser after the auction. Any problems should be referred to the auction master.
7. A 10% buyer's premium will be charged on all purchases, including donated items. The only exception is the show gun; no buyer's premium will be charged on the show gun. All items purchased at the auction must be paid for and picked up between 8AM and 11AM on Sunday at the auction table. Please do not ask for settlement on Saturday evening as it takes several hours to reconcile our figures. Checks for consigned items will also be available after 8AM on Sunday.
8. The Colt Collector's Association and its members are not responsible for omissions, errors, or deletions in the catalog. They also reserve the right to pull any item from the auction deemed not to be in the best interest of the Club. The descriptions in the catalog are not the opinions of the Colt Collector's Association, and the bidder should satisfy his or her self as to the age, condition and authenticity of any items on which he/she intends to bid. Consignors agree to hold harmless the CCA and its officers, directors or other members for any loss incurred.

- 1) Please fill in your name, address, and phone number.**
- 2) Please indicate if you have either a Federal Firearms License or a Curio and Relic License. If so, please bring a copy with you to the auction.**
- 3) If you have more than one item, number them in the first column, and give as thorough a description as possible. The auctioneer will be using your description to describe the item when it comes up for bid. The more information you can provide, the better the auctioneer will be able describe your item, which will increase bidding.**
- 4) Please indicate if you are consigning or donating the item by placing a C or D in the 3<sup>rd</sup> column.**
- 5) If you are consigning, and wish to place a reserve on your item, indicate the amount in the 4<sup>th</sup> column. There will be a \$50 charge to you and a donation to the club if your item does not meet the reserve, and consequently does not sell.**
- 6) Please do not write in the space for LOT NO. or CONSIGNER NO.**
- 7) Please sign and date this form.**
